ENTRY GUIDELINES

Application: All applicants must include the following items with their completed application form:

- Two separate signed checks—one for \$20 (non-refundable) application fee and a post dated check (March 1, 2010) for \$150 booth fee. Checks made payable to **FLAGLER COUNTY ART LEAGUE**
- Self-addressed stamped envelope
- Photo copy of ID
- CD of booth and artwork images

Eligibility: Original work created and presented by the exhibitor only. Kits, imports, or mass-produced items are excluded. No sales agents or business representatives will be permitted. Collaborative work must have all artists' names and signatures on the application. Each exhibitor is responsible for collecting and reporting FL sales tax on Festival sales.

Exhibit: Booth displays must be professional and aesthetically pleasing. Exhibit spaces will accommodate a 10 x 10 tent.

Images: Submit 3 (three) images, as a digital file on a CD marked with your name and art medium.

1 image showing the booth display and 2 images showing two samples of your work. CD will not be returned.

Jurying: A panel of qualified art professionals will jury the exhibit on a point system.

Acceptance Notification:

Notification of application acceptance will be by email no later than March 20, 2010

Commitment & Publicity:

Accepted application is a commitment to exhibit and permission to use images for publicity.

Refund: The \$150 check for the booth fee will be returned to those who are not accepted into the show. After acceptance we are unable to refund fees should you cancel. Nor will they be refunded due to inclement weather, extenuating circumstances, etc.

SET UP AND BREAKDOWN GUIDELINES

SET UP: Friday, 3pm to 6pm or Saturday & Sunday 8am to 9:30am. All vehicles are to be removed to the designated parking area upon completion.

BREAKDOWN: Sunday 5:30pm. Vehicles permitted only after visitors have left the festival area.

SECURITY: Provided Saturday night only. Exhibitors may leave their displays up overnight; however, neither the Flagler County School District, City of Palm Coast nor The Flagler County Art League is liable for any damage or loss.
